**01-2016-02 RESOLUTION TO AUTHORIZE CERTAIN AMENDMENTS TO THE BUDGET ESTABLISHED FOR THE COUNTY'S GENERAL FUND (FUND 101).**

This Resolution is to authorize certain amendments to the budget established for the County's General Fund (**Fund 101**). Amending to reallocate the sum of One Thousand Seven Hundred Dollars (\$1,700.00) within the Circuit Courts existing budget for new computers mandated by **March 1, 2016**. **RESOLUTION TO URGE THE TENNESSEE GENERAL ASSEMBLY AND THE CONGRESS OF THE UNITED STATES OF AMERICA TO TAKE ALL ACTION NECESSARY TO AMEND THE CONSTITUTION OF THE UNITED STATES OF AMERICA TO RETURN POWER OVER THE DEFINITION OF MARRIAGE TO THE PEOPLE OF THE VARIOUS STATES.**

This Resolution is to urge the Tennessee General Assembly and the Congress of the United States of America to take all action necessary to amend the Constitution of the United States of America to return power over the definition of marriage to the people of the various states. We disagree with the decision of the Court in the case of Obergefell v Hodges to invalidate the vote of the people of the State of Tennessee. Shall **Article XL** of the Constitution of the State of Tennessee be amended by adding the following language as a new, appropriately designated section: The historical institution and legal contract solemnizing the relationship of One (1) man and One (1) woman shall be the only legally recognized marital contract in this state. If another state or foreign jurisdiction issues a license for persons to marry and if such marriage is prohibited in this state by the provisions of this section, then the marriage shall be void and unenforceable in this state. Motion by Commissioner Jeff Eby, second by Commissioner Tony Adams to approve the Resolution to urge the Tennessee General Assembly and the Congress of the United States of America to take all action necessary to amend the Constitution of the United States of America to return power over the definition of marriage to the people of the various states passed by a unanimous aye voice vote.
